Located 80 kilometers south of Italy, Malta consists of three English-speaking islands, is one of the safest and most stable country in the world with the modern cosmopolitan lifestyle, rich history, excellent-quality medical care, and high-standard education system in the European Union famous for its fast-growing economy, sunny climate, stable government, Mediterranean's gastronomy, natural beauty, and efficient public services. The new Malta's Granting of Citizenship for Exceptional Services by Direct Investment Regulations renewed in 2020 provides citizenship by a Certificate of Naturalization. Applicants and their dependent family members are granted irrevocable citizenship and a powerful passport who will enjoy benefits of visa-free travel and holding a dual citizenship in exchange of making a significant economic contribution to Malta and after 12 or 36 months of residency status.

TIMELINE

Week 1-2

After retaining MICS and paying its initial professional fee, the first step is to sign the Power of Attorney (POA) document. Then, MICS processing team will provide the applicant with a precise list of civil and financial documents required by the government.

Week 2-4

The MICS legal team will review the documents and financial source carefully and submit Residence application, then the tier 1 due diligence will be conducted.

Month 2-4

MICS performs tier 2 due diligence and ensures correctness and completeness of the application. It may request further information or documents to ensure all the necessary documentation is in order. Tier 3 and 4 Due Diligence will be applied, and MICS will present the Citizenship application to the minister.

Month 12-36

Upon receiving the positive response for the citizenship application from the immigration, the application for the citizenship can be submitted for the VIP option of 12 months processing or the normal 36 months procedure. Upon application approval the applicant needs to fulfill the Exceptional Direct Investment depending on the normal or VIP option. Another investment that must be made plus the Government donation is either the purchase of residential property or annual rent of it. MICS will coordinate a date for the Oath of Allegiance to be done in Malta. When Maltese citizenship is granted, Certificate of Naturalization will be issued for the applicant and his/her family which will be monitored for five years by the Government.
